**Company and Stage Management Offices** for each venue are available on request to the Events Manager.

**Dressing Room Accommodation** allocated for each venue is available on request to the Events Manager.

**Soundproofed Practice Rooms** are available on request to the Events Manager.

**Band Rooms** with change facilities, toilets and instrument storage are located under the Lyric Theatre, Concert Hall and Playhouse stages.

**Rehearsal Areas** are available on request to the Venue Hire Manager.

**Conference Facilities** are available on request to the Venue Hire Manager.

**Recording and Broadcast Facilities** are available on request to the Venue Hire Manager.

**Wardrobe Facilities in the Lyric Theatre and Playhouse.**

Wardrobe facilities are available on request to the Manager Staging.

**Stage Door Security** is provided.

A complete listing of all persons requiring back stage access is to be forwarded to the Events Manager at least ten working days prior to an event entering the Centre, for the preparation of security passes.

Security passes must be prominently worn at all times in order to gain access to the Centre.

## CAR PARKING

## PRODUCTION SERVICES UNIT CHARGES

---

Each venue is hired complete with an allocation of equipment included in the rental.

A charge is levied for the use of additional and specialist equipment provided to hirers.

Charges will be set according to the market and it is requested that initial contact be made with the Managers: Audio/Visual, Lighting or Staging to ascertain rental costs.

## **BROADCAST AND RECORDING CHARGES**

---

### **Television, Film, Live or Taped / Audio, Live or Taped:**

Broadcast Fee - \$300 plus GST.

A Broadcast Allowance may be payable to employees involved in an event. Please request further information from Event Managers.

OB Dock service fee for outside broadcast vehicles - \$200 plus GST

## **LOADING DOCKS**

---

### **Scenery Dock** (Common to all Venues)

Electrically lifted door **5.0m high x 6.5m wide**  
Dock height for loading purposes **1 270mm**  
Load-in facility is capable of accepting two (2) articulated vehicles at one time  
Both vehicles, once docked, may be end-accessed, only one vehicle  
may be side-accessed  
An overhead motorised crane and forklift are available  
Crane **1 000kg SWL**  
Goods Lift **1.7m wide x 2.4m high x 5.0m long**  
(Services wardrobe, docks and dressing rooms)

### **OB Dock** (Common to all Venues)

Electrically lifted door **5m high x 6.5m wide**  
Dock height for loading purposes **1 260mm**  
Available power is 60amp three phase, N&E via Maraschel  
or Neilsen switched outlets

## **VIDEO FACILITIES**

Venue stage views are distributed throughout the centre.

Digital recording, editing and presentation facilities are available.

A selection of pianos including a Steinway D Concert Grand, Kawai Grand pianos of varying sizes and a Hubbard and Broekman Harpsichord are available on request.

All Pianos and Harpsichord are tuned to concert pitch A442.

The Concert Hall Klais Grand Organ is tuned to A442.

All instruments are tuned by QPAC approved tuners to client requirements.

All requirements for the musical instruments are to be directed to the Events Manager.

# WORKPLACE HEALTH AND SAFETY

## **ELECTRICAL TESTING AND TAGGING**

---

Under State legislation all portable electrical equipment, used in or brought into the Centre by hirers, is required to be tested and tagged at least every six months.

## **PYROTECHNICS, FIREARMS AND NAKED FLAME**

Subject to testing and approval by relevant authorities, pyrotechnics, firearms and naked flame may be used in productions.

It should be noted that the use of any pyrotechnics in Queensland is covered by new legislation that requires a licensed (in Queensland) Pyrotechnics Operator
